<p>Annual Interest Rate</p>	<p>These interest rates are in effect when your Account is activated. Standard Rate on Purchases and Fees: 19.99% Standard Rate on Cash Advances, Cash-Like Transactions and Balance Transfers: 22.99% Your interest rates may, <i>at our sole discretion</i>, increase to the Rate of 25.99% for Purchases and Fees and 27.99% for Cash Advances, Cash-Like Transactions and Balance Transfers on your next Statement if you do not make the minimum payment by the due date 2 times in any 12-month period.</p>
<p>Interest-Free Grace Period</p>	<p>The payment due date shown on your Statement will be at least 21 days after the last day of the Statement period shown on your Statement. This period of time is referred to as an interest-free grace period. This means that interest will not be charged on your Purchases and Fees if you pay the full outstanding balance by the payment due date shown on your Statement.</p> <p>There is no interest-free grace period for Cash Advances, Cash-Like Transactions or Balance Transfers, and interest is charged from the date such Transactions occur.</p>
<p>Minimum Payment</p>	<p>The minimum payment shown on each Statement will be the sum of (i) any past due amounts and (ii) any balance over your credit limit PLUS the greater of:</p> <ul style="list-style-type: none"> (a) \$10.00 PLUS current interest and any other Fees (detailed in “OTHER FEES” section); OR (b) 2% of your Statement Balance (or 5% of your Statement Balance if you are resident in Quebec). <p>For all Cardholders, Statement Balances under \$10 are due in full.</p>
<p>Foreign Currency Conversion</p>	<p>All Transactions made in a foreign currency are converted to Canadian dollars at the rate established by Mastercard International in effect on or after the date of the Transaction and no later than the date the Transaction is posted to your Account (which may not be the same date as the date of the Transaction) plus an amount equal to 2.5% of the Transaction amount after it has been converted to Canadian dollars.</p>
<p>Annual Fees</p>	<p>Any Rogers Bank Mastercard (except the Chatr Secured Mastercard): \$0.00 Chatr Secured Mastercard: Primary Cardholder: \$60.00 (payable in twelve equal monthly installments of \$5.00 each and charged on the last day of the Statement period after your first Transaction is made and posted to your Account and charged monthly thereafter on the last day of each Statement period); Authorized User(s): \$0.00</p>

Other Fees

To be charged on the day the Transaction or event occurs, unless otherwise specified.

Over Limit Fee: **\$29.00** when your outstanding Balance exceeds your credit limit; fee is charged only **1** time per Statement period. This fee is not applicable to residents of Quebec.

Cash Advance Fee: **\$5.00** each time you obtain a cash advance at a financial institution or automated banking machine located inside or outside Canada, and each time you conduct a Cash-Like Transaction.

Dishonoured Payment Fee: **\$42.00** each time a payment you make from or to your Account is dishonoured.

Statement and Transaction Reprint Fee: **\$5.00** for an additional copy of your Statement or to reprint a Transaction record. There is no fee for a Transaction reprint for residents of Quebec.

Credit Balance Refund Fee: **\$20.00** for manual cheque requests only.

Fee for Balance Transfers: **3%** of the amount of each Balance Transfer that we may offer to you at a promotional interest rate which is an interest rate that is lower than the standard interest rate that applies to Balance Transfers on your Account. We may waive or lower this **3%** fee at the time the promotional interest rate offer is made to you. You will be advised of the exact fee that applies at the time the offer is made. This fee will be charged on the day that the Balance Transfer is posted to your account.

Inactive Account Fee: If on the last day of the Statement period shown on your Statement there is a credit balance on your Account and there has been no activity on your Account (meaning no debits, credits, interest or fees) for the preceding **12** consecutive months, your Account will be charged a fee equal to the lesser of **\$10.00** and the amount of the credit balance.
